## Motion Minutes:

Mrs. Fields voiced concern of a 3 year contract for the Bill Duncan site. The site has had 6 administrators over the past 2 years compared to two administrators at the Don E Woods site.

Mr. Harris commented that the school district, a non-profit organization, should be able to run the schools at a lower cost than a for-profit organization.

Dr. Reddout stated there is a level of academic achievement and improvement expected of the schools. She would like to see the two schools with separate contracts; a three year contract would be appropriate for the Don E. Woods site, but not for the Bill Duncan site.

Mr. Bridges reported that the contract presented has already been negotiated; the Board can approve or reject it. If the vote is to reject it, the Board may provide suggestions to the Superintendent for further negotiations. If Excel is in agreement, the existing contract may be extended until further negotiations can be held.

Mrs. Cunningham commented that Excel has had the centers for one year. Allowing them a three year contract, would provide them the opportunity to replicate the programs being used at the Don E. Woods site at the Bill Duncan site. After a specified time frame, six months to one year, the School Board can terminate the contract if improvements are not being seen at the Bill Duncan site.
