R-62 2011 - 2012 Final Budget and Millage Rates

Mrs. Wright stated she did not see where the final budget supports the Strategic Plan. Dr. Nickell clarified that prior plans did address areas (ie. transportation, facilities) that were supported by the budget. The 2011-2014 Strategic Plan focuses on student achievement.

##### Minutes:

David Lewis, Associate Superintendent, and Rebecca Braaten, Director of Academic Rigor, provided an overview of the advanced placement programs available to students.

In 2009, the district received a \$2.7 million dollar grant to increase AP participation and performance of economically disadvantaged students. Over a 5-year period, student participation in AP courses has increased from 3,000 to 8,000. Student participation and pass rates should mirror the demographic profile of the school.

SpringBoard Curriculum: (Pre-AP program for grades 6-12 In English Language Arts and Mathematics)

APIP Grant Schools: Crystal Lake Middle, Denison Middle, Lake Gibson Middle, Mulberry Middle, Sleepy Hill Middle, Southwest Middle, Westwood Middle, Auburndale High, Mulberry High, Lakeland High, Lake Gibson High, Lake Region High, Winter Haven High, and Fort Meade Middle Senior.

##### S.T.E.A.M. Academies:

1. Reduce the attrition of high achieving students leaving middle schools below grade level: 1 & 2.
2. Increase the number of economically disadvantaged students taking advanced courses
3. Build an AP pipeline that focuses on a college bound culture
4. Increase student participation in co-curricular activities

Polk County is one of the few districts in the country where the number of students enrolled in AP courses grew as well as those passing the AP courses.

##### Dual Enrollment:

Eliminate program barriers, increase DE participation rates, sustain DE pass rates

Barriers: Low enrollment numbers (approximately 650 students district-wide per term); lack of student transportation to Polk State and South Florida Community Colleges; number of eligible dual enrollment teachers on our high

school campuses.

Current Initiatives: District Dual Enrollment contract; District AP and DE Articulation Guide; offer graduate math and science coursework through USF Polytechnic (funded through RTTT); expand DE offerings on high school campuses based on current teacher credentials.

PRISM: Teacher Recognition Program (Scheduled for September 22, 2011 at the Orlando Science Center)

18 Regional Teacher Finalists: 4 elementary science, 6 secondary science, 4 elementary math and 4 secondary math.

22 Regional Student Finalists have been honored since 2008: Qualified as 7th graders; recognized for academic and co-curricular achievements related to math, science, and technology; receive a \$250 Savings Bond.

An additional 8 PRISM Student Finalists will be recognized at the Superintendent's Evening of Special Recognitions on November 10, 2011.

Mrs. Sellers suggested this information be presented at a Polk Vision Education Committee meeting.
