Minutes:

Mark Grey, Assistant Superintendent of Business Services, voiced his appreciation of Audra Curts, Director of Finance, and the Business Services staff for their work in creating the budget book.

According to Dr. Eric Smith, Commissioner of Education, it is thought that Florida will have approximately 10,000 less students than last year; and, because of the economic conditions, the future growth pattern is anticipated to be significantly slow. Therefore, the budget is built on very conservative numbers. Our goal is to keep all our employees working.

SPEAKERS:

Marianne Capozziello, President of Polk Education Association, commented that during the work session earlier today it was mentioned that monies had been set aside two years ago in preparation for an upgrade to the SAP system. She challenged the School Board to make similar long range plans for employee salary step increases.

Doug Brenner asked if the proposed millage is the same that was published. Mr. Grey reported that it is.

School Board Member Tim Harris spoke against the Supplemental Local Effort (.25 mill) being designated to fund employee benefits.

Kay Fields spoke in support of Marianne's request to look at long-range planning for employee salaries and step increases.

Dick Mullenax would like the idea discussed at the upcoming retreat.

Frank O'Reilly emphasized that the Stimulus Funds are for two years only. \$74 million will be hard to replace in a downward economy. Be careful of what you promise and commit for the future.

Hazel Sellers commented that the Supplemental Funds designated for employee benefits are, to her, a critical need. Serving on the Insurance Committee, she knows there are employees that do not have funds for medications for themselves or their families. It is a tangible need.

Margaret Lofton voiced her support in setting aside funds to provide for employee salaries
