Commented on the wonderful arts program events that have been scheduled over the past month.

Visited Osceola School Board along with former school board member, Jack English, to provide them information on Polk County's student uniform dress code.

Winter Haven Chamber of Commerce has a goal to add 60 new mentors to the schools; the goal of the District's Diversity Council is to add 100 new members by Martin Luther King Day (the third Monday in January). She encouraged school board members to actively recruit mentors to help reach these goals.

ESE Alternative Assessment was a topic of discussion several work sessions ago. She has heard comments from staff that it took hours to prepare materials (cut and correlate items) and days to administer the test. She would have a follow up on what impact the

pilot has had.

It was noted that Nancy Woolcock, Assistant Superintendent of Learning Support, had requested for all teachers to report the amount of time used to prepare and administer the test. On an average it was between 2-8 hours to assemble the test. She has had a conference call with the Chancellor and they are looking into reducing the numbers and having the format delivered to the districts ready for use. There was also a cost for substitutes and extra hours for teachers.

Dr. Reddout met with PEA representatives to hear their concerns and suggested they share their issues with each individual school board member. Some of their issues were 9th grade centers, 25% of instructional time spent on assessment, scientific standards, ESE and inclusion, not making AYP, and an overall feeling of low morale and burn out.
