### Contract for Parent/Guardians

By choosing to enroll a child at South McKeel Academy, parents provide their child with an exciting educational opportunity. Registration of a student indicates that parents or guardians have accepted the responsibility to provide the proper support, encouragement, guidance and home environment to foster the best possible learning situation. Failure to comply with school rules or terms of this contract may result in dismissal from South McKeel Academy. Please read the following expectations carefully.

1. I understand that my child is expected to attend school every day, to arrive promptly, and to remain throughout the scheduled hours. I agree to schedule medical appointments outside school hours. Excessive tardiness and/or absences may result in my child being placed on attendance probation and/or dismissal from South McKeel Academy.
2. I understand that it is my responsibility to notify the school if my child is absent, or is to be released in the custody of another adult in order to leave the school grounds. (Proper ID along with the adult name must be on the emergency card.)
3. I understand that my child is to adhere to the uniform dress code and discipline policies of the school. Failure to follow school rules may result in my child being placed on behavior probation and/or may result in dismissal from South McKeel Academy. Any student who commits a major violation of the code of conduct will be immediately dismissed from school.
4. I understand that as a parent I must be supportive of my child and his/her school. I understand that I (or an adult representative) am **required** to attend parent conferences, school meetings, and other activities sponsored by the school.
5. I understand that it is my responsibility to review all homework and communications (this includes interims and report cards be signed) as requested. South McKeel Academy checkbooks (where used) and academic planners should be reviewed **daily**.
6. I understand that my child is participating in a rigorous academic program that may include Saturday academic remediation in order to maintain continuous academic progress and desirable work habits. Failure to maintain continuous academic progress or non attendance of Saturday academic remediation may result in my child being placed on academic probation and/or dismissal from South McKeel Academy.
7. I understand that I (or my designee) must review my child's schoolwork frequently and as needed with his/her team of teachers.
8. I understand that it is my responsibility to provide the school with the appropriate documents when my phone number, address and/or other important changes on my child's emergency card.
9. I understand that my child must participate in our career shadowing program (only at some grade levels).
10. I understand that my child must meet the requirements in the Promotion and Grading Policies.
11. In accordance with South McKeel Academy's Academic Code of Honesty, I understand that all my child's work must be their own.
12. I understand that it is my responsibility to provide transportation if my child is assigned after school study hall.
13. I agree to pick up, or have my child picked up by another person, on time from all school activities.
