#### Minutes:

Dr. Nickell recognized Cheryl Marino, a social worker with Polk County Public Schools, who was named Social Worker of the Year by the Heartland Unit of the National Association of Social Workers (NASW), Florida Chapter. The Heartland Unit of the NASW-Florida Chapter includes Polk, Highlands and Hardee counties. Cheryl has a focus with working with special needs children and their families. She established a district wide support group for parents of students with disabilities. The group works on outreach programs to these families.

**The Superintendent also reported that 180 Polk County students who meet the federal government guidelines of being homeless will benefit from the generosity of the Polk Education Media Association (PEMA), a professional organization of library media specialists in the Polk County Public Schools. The school district's library media specialists started a countywide book drive at the beginning of the 2010-2011 school year to provide books to needy students.**
