Dear Parent,

Your child is zoned for Lake Alfred Addair Middle, which receives federal Title I funds to assist students in meeting state achievement standards for Adequate Yearly Progress (AYP). Last year, your child's school did not meet these standards. If your child's school does not make AYP for 2008-2009, it will again be identified as a *School in Need of Improvement* under the federal No Child Left Behind (NCLB) law. This designation alone does not indicate a failing school, but provides a focus on areas for school improvement by principals, teachers, and parents.

If Lake Alfred Addair Middle meets the AYP standards for 2008-2009 your option will be Supplemental Educational Services (free tutoring). If your child is eligible for free or reduced-priced lunch, you may apply to receive free tutoring. We will send you additional information about free tutoring during the summer, along with a separate application.

If Lake Alfred Addair Middle does not meet the AYP standards for 2008-2009 your options are:

- To have your child remain at Lake Alfred Addair Middle.
- If your child is eligible for free or reduced-priced lunch, you may choose for your child to remain at the current school and apply to receive free tutoring "Supplemental Educational Services".
- You may choose to apply to transfer your child to one of the schools listed below. If demand for transportation exceeds available funds, by law, placement and transportation will be prioritized to the lowest achieving low-income students.

If you want to apply to transfer your child to another public school, your school options are as follows:

Stambaugh Middle	07/08 School Grade C	Met 77 % of AYP standards
Denison Middle	07/08 School Grade C	Met 69 % of AYP standards
Lake Alfred Addair Middle	07/08 School Grade C	Met 82 % of AYP standards
